### The Proper Entry

Ground Floor, Entry Lobby, and Amenities

Stunning 5,000 square foot art-filled lobby with dramatic 16'- ceiling, an imposing front desk with 24/7 concierge service, and 150 ft of glass frontage on Midtown Blvd and the East Park.

Designed by award-winning, New York-based Meyer Davis Studio, the space is envisioned as an art gallery interacting with both Midtown Blvd and the outdoor parks and paseos.

Connections to the pet spa, mail room, and delivery room.

A ground-floor café adjacent to the lobby offers a place to recharge in the morning with coffee and pastries before heading into the neighborhood.

Spacious, fully finished open-concept floor plans include studios, one- and two-bedroom residences, with 9-foot-plus ceiling heights.
